Ethiopia Concludes High-Level Business Forum, Securing Over \$1.6 Billion in Investment Deals **Amidst Bold Economic Transformation Push**

The Invest in Ethiopia High-Level Business Forum 2025 concluded today in Addis Ababa, marking a significant step in the country's drive to attract foreign investment and foster private sector growth. The two-day event, which gathered global investors and key stakeholders, highlighted Ethiopia's ongoing comprehensive economic reforms and resulted in the signing of five major investment deals totaling over \$1.6 billion USD.



Minister of Finance of the Federal Democratic Republic of Ethiopia, H.E. 
H. E. Mr. Ahmed Shide reflected on the success of the forum, highlighting four key achievements. Firstly, he emphasized how the event effectively communicated Ethiopia's policy reforms and reaffirmed the country's commitment to fostering a vibrant private sector. Secondly, the forum successfully showcased a diverse array of investment, trade, and business opportunities, attracting interest from various stakeholders. Thirdly, it served as a vital platform for networking, which led to the securing of significant investment deals, culminating in the signing of agreements worth over \$1.6 billion USD in investment capital. Lastly, Minister Shide underscored how the forum reinforced investor confidence in Ethiopia's ongoing economic transformation, demonstrating the country's strong dedication to irreversible and forward-looking policy reforms that underpin its development trajectory.



His Excellency Dr. Zeleke, Commissioner of the Ethiopian Investment Commission (EIC), in his closing remarks, celebrated the success of the forum, noting it served as a vital bridge connecting global investors with government, private Ethiopian sector. and the development community. Dr. Zeleke emphasized that creating a favorable investment climate is one of the central pillars of the Ethiopian government's Homegrown Economic Reform Agenda. He highlighted the country's immense potential across various sectors, including manufacturing, services, and Acknowledging that challenges persist, he reaffirmed the commitment of the EIC, in collaboration with stakeholders, to addressing and resolving concerns raised by investors, with a key priority being improved intergovernmental coordination.

Adding to the positive outlook, His Excellency Ahmed Shide stated his hope that the forum surpassed expectations, delivering comprehensive insights into Ethiopia's investment landscape and fostering meaningful connections, fresh perspectives, and opportunities for impactful collaboration. Minister Shide firmly believes the forum powerfully underscored Ethiopia's vast potential and clearly reflected the government's strong commitment to fostering a business-friendly environment that embraces innovation, nurtures entrepreneurship, and advances sustainable growth.

Minister Ahmed Shide announced that the Invest in Ethiopia High-Level Business Forum is set to become a key annual event, serving as a cornerstone of the national investment promotion strategy, supported by strong public-private dialogue mechanisms. He concluded by reiterating the strong commitment to fostering a vibrant and competitive private sector, offering targeted incentives, and proactively addressing investor concerns.



Ethiopia and Denmark Sign 238.4 million USD Bilateral Development Agreement, Reinforcing a Longstanding Partnership

The Government of Ethiopia and the Royal today Government formalized significant bilateral development agreement, the Danish-Ethiopian Bilateral Development Programme for the period 2025 to 2029. The signing ceremony, held at the Ministry of Finance, signifies a deepening partnership and enduring commitment between the two nations. This ambitious five-year program, backed by a substantial contribution of USD 238.4 million, stands out as one of Denmark's largest global development aid programs.



Semereta Sewasew, State Minister of Finance, speaking on behalf of the Government of Ethiopia, offered profound gratitude for Denmark's unwavering support. "The programme we are launching today... comes at a very important time for Ethiopia. We are emerging from a difficult period of conflict and global economic challenges, and are now working hard to rebuild what has been lost—homes, livelihoods, and most importantly, hope".

Ambassador Sune Krogstrup of the Royal Danish Embassy to Ethiopia highlighted this, stating, "This is a testament to the strong bilateral relationship between Ethiopia and Denmark and the excellent partnership that we have enjoyed throughout the years".

"Our two nations have enjoyed a century of friendship with diplomatic ties dating back to 1967," State Minister Sewasew remarked, emphasizing that beyond formalities, "the relationship has been about partnership—rooted in trust, mutual respect, and a shared commitment to building a better future for our people".

The State Minister underscored the critical timing of the program. She further elaborated on the direct impact, noting, "This partnership will support some of the most vulnerable Ethiopian families who are striving to recover their livelihoods, young people who are looking to work and communities that are adapting with changes in climate". This, she added, "directly aligns with our national plan and reflects the people-centered vision we have for development in Ethiopia".

Ambassador Krogstrup expressed his delight in signing the agreement, which he confirmed was "developed in close partnership with the Ethiopian government". He noted, "Ethiopia and Denmark share many priorities, and most of them are reflected in this program". Key areas of support will include "water, electricity, agriculture, social cohesion and social safety net which is very important in these times of change".

State Minister Semereta Sewasew particularly welcomed the strong emphasis on green growth, stating it "deeply resonates with our ambitions under the Green Legacy Initiative". She explained that "whether through climate-smart agriculture, forestry integration [or] access to clean energy, your support our long-term sustainability sovereignty ambitions". Denmark's focus on "peace, human rights, [and] social cohesion" also "speaks to the heart of our nation," especially as "Ethiopia is in the midst of a national dialogue process—bringing together diverse voices and building bridges".

The Ambassador conveyed his confidence that this program will "pave the way for an even deeper cooperation between Ethiopia and Denmark" and that the partnership "will continue to grow over the next five years". He concluded by affirming, "Ethiopia can count on the support of the government of Denmark, of the people of Denmark".

Reaffirming Ethiopia's commitment, State Minister Sewasew stated, "We are fully committed to the success of this program. We will work closely with you to ensure that these programs translate into real and lasting improvement in the lives of our people". She concluded by extending gratitude, saying, "Thank you for believing in Ethiopia".

Kenya and Ethiopia Strengthen Economic and Digital Ties at Landmark HoAGDP Meeting in Addis Ababa

High-level officials from Kenya and Ethiopia gathered today in Addis Ababa to advance the Horn of Africa Gateway Development Project (HoAGDP), a key initiative aimed at boosting infrastructure, trade, and digital connectivity across the region. Ethiopian Finance Minister Ahmed Shide highlighted the importance of these efforts, stating, "The proposed bridges at Suftu and Rhamu are more than just infrastructure—they embody our joint commitment to economic growth, cross-border trade, and job creation." He also emphasized the importance of establishing a One-Stop Border Post (OSBP) at Rhamu to streamline customs procedures and promote efficiency.



Kenya's Cabinet Secretary for the National Treasury, Hon. bridge works, with joint mechanisms in place to John Mbadi, expressed his enthusiasm for the partnership, ensure quality control. remarking, "I am pleased to participate in this vital mission Shide emphasized the human benefits, stating, under the HoAGDP." On digital connectivity, Shide emphasized the vast opportunities ahead, noting, "We recognize the potential of extending high-capacity fiber optic infrastructure to Ethiopia, with a possible link to Djibouti. This digital backbone will boost trade, improve government services, and connect our people more efficiently." Dr. Workineh Gebeyehu added that digital transformation is critical, pointing out that "only 23% of the Mandera Triangle currently has reliable internet access," and stressed that the project supports ICT use for revenue collection, streamlined customs processes, and enhanced transparency.

Discussions focused infrastructure on developments, including bridge construction, Trade Facilitation Centers, and the operationalization of the OSBP—whether unilaterally or jointly. The leaders agreed on conducting site visits for optimal locations, implementing joint inspections during construction, and preparing for the official launch of these projects. 


